Five Year Gravel Plan Review Re:

#### Overview

The purpose of this Memo is to provide Council with information for Review of Municipality of Whitestone Five-Year Gravel Road program and consideration of Road Needs Study recommendations.

# Background:

In 2020 R.J. Burnside & Associates Limited (Burnside) was retained by Whitestone to conduct a Road Needs Study (RNS). The review of the road network (103.13km centre line) was completed in May of 2020 with Brian Sheridan Roads/Facilities Superintendent. The review was based on a snapshot in time representing the findings of the May 2020 inspection. The gravel portion of the RNS identified and provided recommendations for on going capital and maintenance requirements. Structural condition ratings were assigned to each road segment, along with recommendations. It is important to point out that some of the road segments combine in both year-round maintained, and seasonally maintained portions of road.

#### **Year-Round Maintained Roads:**

- Year-round maintained roads receive consistent attention and upkeep throughout all seasons.
- o These roads are regularly monitored and maintained to ensure they remain passable and safe for travel year-round, regardless of weather conditions.
- o Maintenance activities on year-round maintained roads typically include snow removal during winter months, grading, pothole repair, drainage maintenance, and vegetation management.
- Year-round maintained roads often serve as vital transportation arteries for residents, businesses, and emergency services, requiring a higher level of service to ensure accessibility and safety at all times.

 The municipality allocates significant resources to maintain year-round roads to a high standard, recognizing their critical importance to the community's daily life and economic activities

#### **Seasonal Maintained Roads:**

- Seasonal maintained roads receive maintenance primarily during certain times of the year, typically the end of May to mid October during warmer months when weather conditions permit. Should an emergency arise Public Works will review and address the situation.
- o These roads do not receive snow removal during winter months.
- Maintenance on seasonal roads may include grading, spot gravel application, and vegetation control to ensure passability and safety during the warmer months.
- Due to their seasonal nature, these roads may experience more significant wear and tear, requiring periodic maintenance to address issues such as washouts, potholes, and erosion.
- The level of service on seasonal maintained roads are lower compared to yearround maintained roads, reflecting the reduced frequency of maintenance activities and the prioritization of resources on critical routes.

Based on the findings of the RNS, Burnside recommended a gravel maintenance program totaling \$4.1 million over a 10-year period. This program represents a dynamic framework, intended to evolve over time as new data and insights emerge. As such, it serves as a living document, adaptable to changing circumstances recognized by Public Works staff and informed by ongoing assessments of our road infrastructure. By proactively addressing maintenance needs and leveraging available funds we strive to enhance the overall quality of life for our residents and visitors alike.

Consideration for completing a road review in the early portion of spring, rather than late spring, offers several advantages.

Conducting the review early allows Public Works to identify potential issues with road infrastructure before they escalate. By catching problems such as drainage issues early on, Public Works can plan and prioritize repairs efficiently, minimizing the risk of further damage and costly emergency interventions later in the season.

Early spring road reviews enable Public Works to allocate resources strategically. By identifying repair needs upfront, they can allocate budgets more effectively, securing necessary funding for maintenance and repairs before competing demands arise. This proactive approach ensures that resources are used efficiently and that road repair projects can be completed promptly, maximizing the lifespan of infrastructure assets.

 Community Satisfaction: Timely road maintenance fosters community satisfaction and trust in our Municipality. By addressing road issues promptly, Whitestone demonstrate responsiveness to residents' concerns and prioritize the upkeep of essential infrastructure. This proactive approach helps build positive relationships with the community and enhances public confidence in the municipality's ability to manage and maintain local roads effectively. 2. Long-Term Cost Savings: Early spring road reviews contribute to long-term cost savings for Whitestone. By identifying and addressing maintenance needs promptly, Whitestone can prevent minor issues from escalating into major infrastructure problems that require costly repairs. Investing in proactive maintenance ultimately saves taxpayer dollars by extending the lifespan of road infrastructure and minimizing the need for expensive emergency interventions.

Addressing the levels of service on our gravel roads necessitates larger budgets to tackle ongoing challenges. Recognizing these issues, Public Works Staff has initiated a longer-term review of the road network to address pressing concerns affecting our gravel roads.

One such issue highlights the severity of the situation: the grader becoming stuck on Lorimer Lake Road during a particularly challenging spring thaw in 2021. This type of incident although becoming less frequent, underscores the struggle to maintain adequate levels of service, as evidenced this spring on Edgewood by an individual being stranded due to impassable road conditions, forcing them to resort to walking home.

Additionally, roads like Parker Bay, Crown Retreats, and Quinn Road have faced their own set of challenges, with insufficient gravel leading to the grader encountering bedrock, resulting in damage to equipment. These roads have now been addressed due to identifying the needs and utilizing maintenance gravel diligently at the right time. Such incidents underscore the urgent need for comprehensive road maintenance strategies.

During the recent spring season, WahWashKesh Road endured another bout of difficult conditions, with deep mud and ruts hindering residents' access to their homes. WahWashKesh Road is a vital year-round route with significant traffic volumes, further emphasizing the importance of addressing its maintenance needs promptly and effectively, hence the planned works for 2024.

Despite operating within financial constraints, Public Works is committed to maintaining essential services. Figure 1 illustrates that only year-round maintained roads receive consistent attention, while seasonal roads rely on sporadic gravel replenishment from Public Works stockpiles.

To ensure the continued functionality and safety of our road network, increased budgetary allocations are imperative. These resources will enable Public Works to implement proactive maintenance measures, address existing challenges, and uphold satisfactory levels of service for all residents and visitors traversing Whitestone's roads.

**Figure 2** highlights roads identified in the RNS that require funding sources for necessary maintenance and improvements. It's worth noting that certain shorter roads with very low volume traffic (less than 50 AADT, Average Annual Daily Traffic) may be addressed using resources from the Public Works gravel stockpile in years when emergency road repairs are not required or minor surface corrections. Example of such roads are William Street, Sackville. These roads do not require the same level of service the high-volume roads in the Municipality. It's important to highlight that our current gravel plan underwent thorough review and consultation with both our grader operators and Public Works staff. This collaborative effort ensured that our plan aligned closely with on-the-ground realities and operational insights.

**Figure 2** within our gravel plan identifies roads in need of funding, such as Maple Island Road, Ladds Road, Labrash Road, and Boundary Spur Road. These roads had received some level of gravel maintenance prior to 2020, indicating ongoing needs for continued attention and investment.

In the case of Neslon Clelland Road, its relatively low average annual daily traffic (AADT) of below 50 led to its prioritization being adjusted within our list for receiving gravel. While recognizing its importance, this adjustment reflects a strategic approach to allocating resources based on traffic patterns and usage to ensure equitable distribution across our road network.

Managing limited gravel resources is a priority and a yearly consideration during the early spring review and budget process.

#### Notes:

- 1. The NORDS Grant is providing funding for gravel roads in the amount of \$119,000 per year for 2021, 2022, 2023, 2024 and 2025. The 2021 and 2022 funds were paid to the Municipality 2022.
- 2. In concert with the NORD Grant funding and the recognition in the RNS that additional resources need to be budgeted for gravel roads, budgets and expenditures have increased significantly since 2020
- 3. My first summer season as Public Works Manager in 2021, the Municipality's Public Works department faced challenges addressing seasonal roads, resulting in increased fuel costs due to the utilization of in-house trucks. The overruns in fuel costs incurred during the 2021 season were effectively balanced by reallocating funds from the summer maintenance budget designated for gravel.

This adjustment was made possible by sourcing gravel directly from the quarry, thereby leveraging existing resources to address the increased fuel expenditure. The larger contracted trucks faced challenges navigating our seasonal roads. Despite being less efficient than larger trucks, our smaller truck proved invaluable in accessing narrow or challenging roads, allowing us to dump gravel and

maneuver effectively. Their compact size and agility enabled it to navigate tight spaces and turn around, the same is true for our snow plow operations.

It's worth noting that in previous years, we rented a tractor equipped with a drag to grade summer roads. This was necessary as our grader lacked the capacity to navigate over bedrock and large boulders efficiently for both Shawanaga Lake and Lorimer Lake seasonal roads. By adapting our approach and making strategic equipment decisions, our grader is more effective in managing our seasonal roads.

#### **Background:**

Tender 2024-03 for the Supply, Deliver and Spread 10,000 Tonnes of Granular Materials, was released on February 02, 2024 with a closing date of February 29, 2024 at 12:00 pm.

The Tender was advertised on the Municipal website, and placed with the Parry Sound North Star online newspaper February 02, 2024.

Five (5) potential bidders received tenders for this project.

### **Analysis:**

Tenders were opened publicly opened on February 29, 2024 at 12:30 pm and the following bids were received:

The tender from Weeks Construction Inc, is compliant and recommended for award. Weeks Construction Inc. plan to supply from their Burks Falls Quarry located on Hwy 520.
