Message from the Government of Ontario

- in response to publicly reported comments calling for amalgamation by Parry Sound Mayor McGarvey at the time of the recent FONOM conference

There will be no forced amalgamation in West Parry Sound

 The Government of Ontario may be prepared to assist municipalities wishing to amalgamate by sponsoring an independent study of opportunities, impacts, and costs

There appears to be little support for amalgamation within West Parry Sound municipalities. So there is no cause for consternation or panic.

This is not a new subject

- The Parry Sound District Restructuring Commission that led to the creation of Whitestone in 2000 considered various amalgamation / consolidation options
- The Town of Parry Sound has consistently called for amalgamation as a means of expanding its tax base
- Many provincial politicians and public servants I have spoken to over the years believe that Parry Sound District needs further restructuring – at least an upper-tier government
- Last year, the mayors of Sundridge and Joly called for an amalgamation study in their area

Why does this keep coming up?

There are some underlying issues.....

- 22 Municipalities in Parry Sound District, including the Town of Parry Sound
- Many of them are below "critical mass" in terms of population and tax base
- Wide disparities in infrastructure, services, and tax rates
- No upper-tier government
- Growing need for shared services
- Development charges in Parry Sound / Seguin Twp.
- Other considerations (e.g., watershed management, aboriginal land claims)

Being below critical mass means being...

- Unable to attract and retain competent managerial and professional / technical staff
- Unable to provide needed / wanted programs and services
- Unable to plan, prepare, and invest for the future
- Unable to do a good job of energy conservation, climate mitigation, emergency planning, environmental stewardship, watershed management, and like responsibilities
- Unable to meet all the financial and legal obligations of a municipality in the 21st century

My personal position

 I am categorically opposed to forced amalgamation or full upper-tier government for west Parry Sound District

"I will continue to oppose vigorously any attempt to impose an additional layer of governance on us or to amalgamate us with other municipalities."

 At the same time, I am committed to collaboration with our neighbouring municipalities on opportunities to share resources and services for our mutual benefit and the greater good of the District

My reasoning

- We Ontarians already have more government in total (i.e., all levels combined) than we need and can afford
- I can't see how Whitestone residents could benefit from amalgamation or upper-tier government
- Amalgamations are costly and contentious and rarely result in cost savings
- Each WPS municipality has unique characteristics and needs
- We don't want to give up our local autonomy

My prognosis

- The complexity and cost of local government will continue to grow
- Some reorganization of Parry Sound District is likely inevitable as it continues to grow
- More shared services are necessary and inevitable
- Our success depends on the success of the Town of Parry Sound

My prescription

- If there is a regional study of opportunities for shared services, we must participate.
- If there is no study, we must initiate further discussions with our neighbours (as per our Strategic Plan).
- We must keep our seat at the table. If we don't, we will be left out and left behind.
- We must continue to demonstrate that we are capable of governing ourselves and managing our affairs responsibly. (It's not a right; it's a privilege.)
